YOUTH PROTECTION PROGRAM

As you may know by now, EAA has introduced a new policy for all members working with youth in any EAA sponsored events. It is comprised of a background check which I hope you will not feel invasive, but unfortunately at this place in time, is relevant. The program includes the protection policy procedures/guidelines, a short "test" and information to have a complete background check performed by a third party Agency - at no cost to you. None of your personal information will be shared and EAA only receives notification that you are in compliance with the necessary standards. EAA then sends you a certificate which is valid for 3 years.



All YE pilots, YE Coordinators and Field Representatives must successfully complete training and requirements by May 1, 2016. This will also be important for anyone


