## HANGAR CAPITAL CAMPAIGN UPDATE

With the exception of the outstanding Hangar Fund Challenge, EAA Chapter 44 will continue in a “quiet phase” of what will eventually become a public Capital Campaign for the hangar addition. Your Board of Directors will ultimately determine when to proceed with a major fund raising campaign for the hangar addition. To be avoided is a premature launch when your BOD is not fully convinced that ‘now’ is the time to proceed.



Meanwhile, behind the scenes, the strategy is to get the building blocks in place for such a major fund raising effort. The Board of Directors has, for example, established both a Mission Statement, a Vision Statement, a Case Statement (which defines the purpose and uses

of a hangar facility), and a Working Plan that puts ‘meat on the bones’ of our mission and vision. In addition, a Steering Committee chaired by Rob Williams meets periodically to weigh-in on steps that can be taken now to be ready for that day when a formal campaign is launched.

In my role as campaign Coordinator, my emphasis has been on striving to be ready when the time is right. My role is to coordinate in preparation for what will eventually be a major fund raising effort. My responsibility to the BOD not advocacy for the project. That is our Board’s responsibility.

However, we can be very proud of our Boards’ resolve to build and to expand the offerings of EAA 44. For example this summer we offered to the community the Ford Tri-Motor event, Young Eagle Aviation Camp, Young Eagle events, KitFox work sessions, support of the Brockport Rotary breakfast, and an AOPA Safety Seminar. This expanding array of services points with confidence to the future. “Yes, we will have a hangar one day.”

Our Hangar Fund is a separate account dedicated to the eventual construction of a hangar. Note that gifts toward the Hangar Fund are gratefully received anytime. Be sure to insert the words ‘Hangar Challenge’ on the memo portion of your check made payable to EAA Chapter 44. By doing so, you double your gift and help us reach the \$10K Challenge goal.

(over 33 hours!) to what single piece of equipment failed, and was responsible for the Eastern Airlines Flight 401 crash that killed 101 of 176 people on board in the Florida Everglades? Believe it or not, it was a \$12.00 light bulb. The crew became so distracted dealing with a blown bulb that they missed their first priority, "Fly the airplane!"

This was not Mark's first visit to western New York, He has been a speaker for AOPA for over 16 years, and in that time has spoken in every one of the 50 states. As an award winning traffic reporter, he also has over 6,500 hours in a Cessna 150. That's a lot of time in a 150!

AOPA's objective in their twice-a-year lecture tour is to increase air safety through evenings filled with fun and air safety education. EAA 44 is lucky to be one of the regular tour stops on the Air Safety Institute tour, and it provides yet another example of how EAA 44 and our Sport Aviation Center continue to grow as an integral part of the western New York aviation culture.

How did they mount what had to be big and heavy cameras back in the day to make these shots which are very familiar to us today? The aerial action photography is amazing to watch. She joins the war effort as an ambulance driver bringing the wounded soldiers, and pilots (see where that is going?), to field hospitals. Was this kind of commitment to serve on the front common for women during WWI? I don’t know, but Director William Wellman DID chose to show her as an active, competent women.

Gary Cooper makes his movie debut as a military student pilot. He dies in the next scene. But he gets credit on the movie posters. Go figure.

And during the whole three-hour experience (with one intermission) one gentleman was playing a beautiful score, written for the original film, that rose and soared with the plot and action. 
